

DECISION ON JOVICA STANIŠIĆ'S URGENT MOTION FOR CONSIDERATION OF RECENT DOMESTIC JURISPRUDENCE

Mr. Mihajlo Bakrač Mr. Vladimir Petrović **THE APPEALS CHAMBER** of the International Residual Mechanism for Criminal Tribunals ("Appeals Chamber" and "Mechanism", respectively);<sup>1</sup>

**NOTING** the judgement pronounced in this case by the Trial Chamber of the Mechanism ("Trial Chamber") on 30 June 2021 and filed in writing on 6 August 2021;<sup>2</sup>

**NOTING** the appeals against the Trial Judgement filed by Mr. Jovica Stanišić ("Stanišić"), Mr. Franko Simatović, and the Office of the Prosecutor of the Mechanism ("Prosecution");<sup>3</sup>

**NOTING** that the parties presented their oral submissions at the hearing of the appeals on 24 and 25 January 2023;<sup>4</sup>

**RECALLING** that, on 10 May 2023, the Appeals Chamber ordered, pursuant to Rule 144(D) of the Rules of Procedure and Evidence of the Mechanism ("Rules"), that the judgement in the present case be pronounced publicly in the Hague Branch of the Mechanism on Wednesday, 31 May 2023;<sup>5</sup>

**BEING SEIZED OF** a motion filed confidentially on 26 May 2023, wherein Stanišić requests that the Appeals Chamber consider a decision of the Supreme Court of the United States of America issued on 18 May 2023 in the case of *Twitter Inc. v. Taamneh et al* ("United States Decision");<sup>6</sup>

**NOTING** Stanišić's submission that the United States Decision is the most recent and authoritative interpretation of common law aiding and abetting liability, and that it is directly relevant to and supports submissions raised in Ground 1 of his appeal against his conviction for aiding and abetting;<sup>7</sup>

**NOTING FURTHER** Stanišić's submission that the United States Decision "trigger[s] the Appeals Chamber's obligation to consider [it] in its assessment" in light of its obligation to consider all relevant jurisprudence including decisions issued after the hearing of an appeal;<sup>8</sup>

**NOTING** that – given the urgency of the matter, the imminence of the judgement on the appeals, and in order to not prejudice Stanišić – the substance of the Prosecution response, filed on 30 May 2023, was not considered and the present decision is being issued without awaiting Stanišić's reply;9

**RECALLING** that the Appeals Chamber may consider post-hearing submissions if they relate to a variation of the grounds of appeal or if it has made a specific request to the parties for further information;<sup>10</sup>

CONSIDERING that the Motion presents the United States Decision in order to buttress arguments raised in Stanišić's appeal and, therefore, does not relate to any variation of a ground of his appeal and the Appeals Chamber has not directed the parties to make additional submissions;

**CONSIDERING FURTHER** that the Appeals Chamber is not bound by the findings of other courts, including domestic courts, 11 and that Stanišić has not demonstrated that the United States Decision is relevant jurisprudence that must be considered by the Appeals Chamber for a fair determination of his appeal;

FINDING that Stanišić has not demonstrated a valid basis for the Appeals Chamber to consider the United States Decision in connection with his appeal;

#### FOR THE FOREGOING REASONS,

#### **HEREBY DISMISSES** the Motion.
